## Terms and Conditions

1. Holidays are from Friday to Friday in the Barn and Potting Shed, and from Thursday to Thursday in the Millers loft (except in the case of Christmas and New Year weeks).  
Holidays commence at 1.30pm on arrival day and end at 10.00 am on departure day.  
The Millers Loft is available from 1.30 pm.
2. A deposit is payable on booking and the balance is due 8 weeks before the commencement of your holiday.
3. If you cancel your holiday we will seek to re-let. If we do so we will refund your payment less £30.00 administration charge. If we do not re-let you will be liable for the full charge. All deposits are non-transferable.
4. You are responsible for the condition of the holiday property, for leaving it clean and tidy and for paying for any breakages or damages.
5. We cannot be held responsible for any loss, damage or injury to you, your visitors or your belongings. Children must be supervised at all times during your stay at Coldgate Mill.
6. The holiday is offered on the understanding that no more than the maximum number of people indicated in our information shall use it and that no smoking is permitted in any of the properties.
7. Only one dog is allowed in Millers Loft, Please speak to Diana first.
8. Access to any of the holiday properties is required at any reasonable time for essential maintenance work or the annual tourist board inspection. Wherever possible this would be done by prior arrangement.
9. In the extreme unlikely event that the holiday property becomes unavailable due to reasons beyond our control, we will do our best to help you find alternative accommodation in the Wooler area and refund all monies in full. We shall not under any further liability.
